I will indemnify and hold NBCR harmless from any claims, lawsuits, injuries, damages, losses, costs, or expense whatsoever sustained by any animal or person in connection with my misconduct or grossly negligent performance of volunteer activities for NBCR or any breach of NBCR's rules, regulations, policies, or programs.

I hereby agree that I am providing volunteer services to NBCR, assisting in pet adoptions. This may also include assisting in adoptions of pets through NBCR at local Petsmart stores. I understand that neither NBCR or Petsmart is responsible for any illness or injury caused by any animals that I come into contact with during my volunteer work.
